Related firefighting foam companies were named as co-defendants in the AFFF firefighting foam action. ²³
Wisconsin	Josh Kaul	March 13, 2022	"Civil environmental enforcement lawsuit against Johnson Controls, Inc. (JCI) and Tyco Fire Products LP (Tyco) for alleged violations of the state's hazardous substance spills law related to discharges of PFAS." ²⁴


