

Bulletin #65, A Little Drop Will Do Ya, September 16, 2022 [Updated Bulletin #23, May 14, 2021, with USEPA's new health advisories<sup>1</sup>]

"Put another way, a single Olympic-sized swimming pool filled with PFOS would contain enough of the chemical to contaminate the drinking water of every American, said Chris Higgins, a professor of civil and environmental engineering at the Colorado School of Mines. A little bit goes a long way."<sup>2</sup>

The contamination reach of PFAS-containing firefighting foams cannot be contained. AFFF is designed to spread.<sup>3</sup> PFAS will go anywhere that water goes. For visualization purposes, Lake Michigan contains one quadrillion gallons of water.<sup>4</sup>

## One drop of PFAS

"Earlier this summer, the EPA released updated lifetime health advisories for several PFAS chemicals, including PFOA and PFOS, setting them at .004 parts per trillion (ppt) and .02 ppt respectively. For context, one part per trillion is the equivalent of one drop of water in an Olympic-sized swimming pool. These advisories and the proposed rule released today leave no doubt that no amount of PFOA and PFOS chemicals are safe for people or wildlife."
